General Terms of AGREEMENT

Parties:*

Sarat Centenary College, Dhaniakhali, Hooghly, WB-712302, herein referred to as "College."
M/s. M.S.S. (Address- 88/1 G.T.Road, East End, Bardhaman, PIN - 713103 (WB), herein referred to as "Vendor."

Purpose:*

The purpose of this Agreement is to outline the terms and conditions under which the Provider will deliver, implement, and support the ERP (Enterprise Resource Planning) software for the College.

Scope of Work:

1. Whereas College is purchasing a domain name <https://camsscollege.in> for hoisting the

College ERP software for maintaining the integrated records of College Administration, Audit and Accounts, Library including all required records of Staff and Students etc.

2. **Whereas College** purchased licensed software for the above mentioned purpose from the Vendor in the year 2012 and subsequently the software were developed and upgraded by the Vendor time to time. The present form of the ERP software (Dot Net and MSSQL 2014/2016 platform) was implemented since April 2019 and there were some subsequent minor modifications/upgradations of the software in the part of the Vendor. The ERP software was hoisted in the domain <https://camsscollege.in> in the servers of the Vendor which now onwards will be hoisted in the domain <https://camsscollege.in> of the server of the Vendor.
3. **Whereas College** has been paying the hiring charges for the same.
4. The data of the College linked with the ERP software is being safely the Vendor.
5. Whereas the present ERP be continued to be hoisted and maintained by the Vendor fulfilling every requirement of the College and also protecting every interest of the College, and College will make payments to the Vendor in same rule as paid for the year ending F.Y.. Vendor will also install the ERP Software in the server system of the College and make arrangement for downloading and updating the data time to time using FTP protocol.
6. Duration of AGREEMENT: This AGREEMENT is renewed upon signing and will have initial duration of Three year from the date of renewal and subsequently may be renewed.
7. Coordination: In order to carry out and fulfil the aims of this agreement, each party will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities.
8. Technical Support: Addendums to this AGREEMENT will be developed for specific technical support activities. These Addendums will provide a detailed description of the role, responsibility, Module. Work plans and reporting requirements will be clearly outlined in the Addendums.
9. Confidentiality: Each party agrees that it shall not, at any time, after executing the activities of this AGREEMENT, disclose any information in relation to these activities or the affairs of business or method of carrying on the business of the other without consent of both parties.
10. Termination of AGREEMENT: The partnership covered by this AGREEMENT shall terminate upon completion of the agreed upon period. The agreement may also be terminated with a written one month notice from either side
11. NOTE:
 - A. The Vendor has to carry out the entire Installation Process etc. including domain and hosting on their own.
 - B. Design, development and installation customization time should be mentioned clearly.

12. Model/ Field / Logic subject to change according to the requirement of the College /Govt. Order, Rules & Regulations within a week from the date of College / Govt. Order, Rules & Regulations within a week from the date of communication to the Vendor by the College.
13. ERP software training should be provided to the users of the College.
14. All coding of ERP software must be handed over to the College after successful installation.
15. Access of all modules must be provided to the authorised representative of the.
16. The Vendor shall be obliged to make necessary changes if needed by the College.






