Persuant to the resolution of the Executive Council dated 14-03-2020 under item No.-425 (Any Other Matter) and as per the Government order No. 86-SSE/20 dated 14.03.2020 issued by the Govt of West Bengal along with Press release issued by the Hon'ble Chief Minister, Government of West Bengal vide No. 85-SSE/20 dated 14.03.2020 in view of the evolving situation on the spread of Novel Corona Virus (COVID-19), it is requested to follow the orders as mentioned below:

- 1. Government order No. 86-SSE/20 dated 14.03.2020
- 2. Press release issued by the Hon'ble Chief Minister, Government of West Bengal vide No. 85-SSE/20 dated 14.03.2020

In compliance with the above mentioned orders, it is notified for information of all concerned that all affiliated Colleges under this University and all Post Graduate Departments of this University will remain closed on and from 16th March, 2020 to 31st March, 2020 in public interest. However all administrative departments of University and affiliated colleges will function for Emergency and essential services.

It is also notified for information that the sports related activities of this University, Seminar, Conference, Workshop of all Departments, if any, will be deferred until further order and Hostels & Guest House of the University will be vacated immediately.

All examinations (both U.G. & P.G.) under this University in all campuses and affiliated colleges will remain suspended during the above-mentioned period. Rescheduled programme will be notified in due course.

The Biometric Attendance will also be stopped immediately until further order. Public entry in Krishna Sayar Uddyan & Meghnad Saha Planetarium will be strictly prohibited until further notice.

Emergency and essential services of the University including University Health Centre will, however, remain open as usual. If any emergency situation arises, the respective Controlling Officer may seek the service of any employee attached to his/her Department/Section during the said period.
